*SD ACPA Contractor Member volume dues are \$2.15 per \$1,000 of concrete pavement related assessable items. In general these items include: Concrete pavement (reinforced, non-reinforced, approach, driveway, median, etc.); Cement treated/stabilized base; Dowel bars/baskets; Drilled/inserted steel bars (dowels, tie-bars, steel bars, etc.); Curb & gutter; Patching (full & partial depth spall/slab repair/replacement); Diamond grinding; Grooving; Slab jacking; Undersealing; Joint sawing/resawing; and Joint/crack sealing/resealing. \$0.55 per \$1000 will also be collected for National dues at the same time for a combined rate of \$2.70 per \$1000. The State Chapter will submit payment to National ACPA upon collection from the contractor. The State Chapter is also responsible for an annual affiliation fee of \$15,000 per year to National ACPA.

AGREEMENT
